ANNUAL APPROPRIATION ORDINANCE FOR THE
VILLAGE OF ALLERTON,
VERMILION COUNTY AND CHAMPAIGN COUNTY, ILLINOIS FOR THE FISCAL
YEAR BEGINNING MAY 1, 2004 AND ENDING APRIL 30, 2005.

WHEREAS, the Board of Trustees of the VILLAGE OF ALLERTON the Counties of Vermilion and Champaign, State of Illinois, has prepared or caused to be prepared a tentative form of the Annual Appropriation for said Village for the fiscal year beginning May 1, 2004 and ending April 30, 2005 and the same has been filed with the Village Clerk and made conveniently available for public inspection in three prominent places within the Village for at least thirty (30) days prior to final action thereon; and

WHEREAS, all other legal requirements have been duly complied with by the Board of Trustees of the Village of Allerton;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF ALLERTON, IN THE COUNTIES OF VERMILION AND CHAMPAIGN, STATE OF ILLINOIS, AS FOLLOWS:

Section 1: That the following sums, or so much thereof as by law may be authorized, be and the same are hereby budgeted, set aside and appropriated for all Village purposes for the fiscal year beginning May 1, 2004, and ending April 30, 2005, and the objects and purposes for which said appropriations are made, and the amounts thereby appropriated for such purposes are as follows:




