

# ANNUAL APPROPRIATION BILL

1-06-14

An ordinance making appropriations for the corporate purposes of the Village of Foosland, Illinois, for the fiscal year commencing on the First day of May A. D. 1906, and ending on the 30th day of April A. D. 1907  
BE IT ORDAINED BY THE President and Board of Trustees of Foosland, Illinois.

Section 1. That the following sums, or so much thereof as may be authorized by law, be and the same are hereby appropriated for the corporate purposes of the Village of Foosland, Illinois, as herein-after specified, for the fiscal year commencing on the First day of May A. D. 1906, and ending on the 30th day of April A. D. 1907, to-wit:


