**ORDINANCE NO. 2006-8-1**

**COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE**

**WHEREAS**, there has been prepared a Tentative Budget and Appropriation Ordinance for the Ivesdale Fire Protection District; and

**WHEREAS**, said Tentative Budget and Appropriation Ordinance was duly presented for public hearing on August 15, 2006, following timely notice thereof;

**NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED BY THE IVESDALE FIRE PROTECTION DISTRICT AS FOLLOWS:**

**Section 1.** That the fiscal year of the Ivesdale Fire Protection District shall be and the same is hereby fixed and declared to be from June 1, 2006, to May 31, 2007.

**Section 2.** That the following Budget, containing an estimate of the receipts and expenditures of the Ivesdale Fire Protection District, shall be and the same is hereby adopted as the Budget of the Ivesdale Fire Protection District for the said fiscal year:

**Section 4.** Any accumulation of funds is being made pursuant to the provisions of 70 ILCS 705/14, for the purpose of procuring fire-fighting apparatus and equipment and repairing and improving District buildings.


**Section 5.** This Ordinance shall be effective following a public hearing held on August 15, 2006.


