COMBINED ANNUAL BUDGET AND APPROPRIATION  
 ORDINANCE FOR THE REVENUE YEAR 2006

ORDINANCE No. 84

BE IT ORDAINED by the Board of Trustees of the Windsor Park Fire Protection District that there is hereby adopted for the revenue year 2006 this combined annual budget and appropriation ordinance of and for the Windsor Park Fire Protection District:

BUDGET

Estimate of current ordinary expenditures contemplated for fiscal year beginning May 1, 2006:

1. For contract with Village of Savoy	\$12,300.00
2. For legal fees	200.00
3. For premium on Trustee's bonds	250.00
4. For tax collection, printing, and secretarial services	100.00

Sources of revenue other than derived from taxes estimated	NONE
Estimated cash expected to be on hand at end of fiscal year other than donations	\$5,000.00

APPROPRIATION


That there is hereby appropriated for the revenue year 2006 for the objects and purposes of the Windsor Park Fire Protection District as itemized and set forth above as numbers 1 through 4 inclusive which said amounts and the total amount of \$12,850.00 are hereby appropriated for the purpose of defraying expenses and liabilities of the Windsor Park Fire Protection District for the revenue year 2006, to be realized out of taxes to be levied on all taxable property within said Fire Protection District.



Notice of said hearing shall be given by publication pursuant to statutes prior to such hearing.


