**ANNUAL BUDGET AND APPROPRIATION ORDINANCE OF THE  
VILLAGE OF BONDVILLE, ILLINOIS**

An ordinance making appropriations for the corporate purposes of the Village of Bondville, Illinois for the fiscal year 2007-2008 (May 1, 2007 through and including April 30, 2008).

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE  
VILLAGE OF BONDVILLE, CHAMPAIGN COUNTY, ILLINOIS, as follows:**

Section 1. The following sums, or so much thereof as may be authorized by law, be and the same are hereby appropriated for the corporate purposes of the Village of Bondville, Illinois to defray all necessary expenses and liabilities of such Village of Bondville, Illinois, as hereinafter specified for the fiscal year 2007-2008.

Section 2. To the extent lawful, any unexpended balance of any items herein appropriated may be expended in meeting any insufficiency in any other items of appropriation made by this ordinance.

Section 3. The several sums of money described above are hereby appropriated from monies received and to be received by the Village of Bondville, Illinois, from all sources.

Section 4. This ordinance shall take effect and be in force from and after its passage, approval, and publication as provided by law.

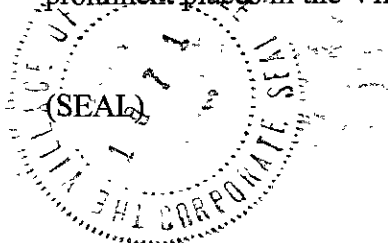
