

**COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE OF THE
BROADLANDS - LONGVIEW FIRE PROTECTION DISTRICT
FOR THE FISCAL YEAR 2007 - 2008
ORDINANCE NO. 72**

An ordinance making appropriations for the corporate purposes of the Broadlands - Longview Fire Protection District in the Counties of Champaign and Douglas, Illinois, for the fiscal year commencing April 1, 2007 and ending March 31, 2008.

BE IT ORDAINED by the Board of Trustees of the Broadlands - Longview Fire Protection District of the Counties of Champaign and Douglas, Illinois, that the following sums, or so much thereof as may be authorized by law, are hereby budgeted and appropriated for the corporate purposes of the Broadlands-Longview Fire Protection District in Champaign and Douglas Counties, Illinois, to defray necessary expenses and liabilities of the District, as hereinafter specified, and that any unexpected balance from any item or items in one general appropriation made by this ordinance may be expended in making up any insufficiencies in any item in the same general appropriation made by this ordinance, for the fiscal year commencing April 1, 2007, and ending March 31, 2008 to wit:
