ORDINANCE # 07-01

BUDGET AND ANNUAL APPROPRIATION ORDINANCE FOR THE EDGE-SCOTT FIRE PROTECTION DISTRICT, CHAMPAIGN COUNTY, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JANUARY 1, 2008, AND ENDING DECEMBER 31, 2008

WHEREAS, the Trustees of the EDGE-SCOTT FIRE PROTECTION DISTRICT in the County of Champaign and State of Illinois have prepared in tentative form a Budget and Annual Appropriation Ordinance and the Secretary of the EDGE-SCOTT FIRE PROTECTION DISTRICT has made the same conveniently available to public inspection for at least thirty (30) days prior to final action thereon; and

WHEREAS, a Public Hearing was held on October 16, 2007, notice of which hearing was given at least thirty (30) days prior thereto by publication of the Notice of Hearing in the Champaign-Urbana News Gazette, a newspaper published within the county in which said fire protection district is located and having general circulation within this fire protection district;

NOW, THEREFORE, be it ordained by the Trustees of the EDGE-SCOTT FIRE PROTECTION DISTRICT of Champaign County, Illinois;

Section 1. That the fiscal year of the EDGE-SCOTT FIRE PROTECTION DISTRICT in the County of Champaign and State of Illinois is hereby fixed and declared to be from January 1, 2008 to December 31, 2008

Section 2. That the following budget, containing an estimate of the receipts and disbursements for the fiscal year beginning January 1, 2008, and ending December 31, 2008, is hereby adopted and shall be in full force and effect from and after this date.


