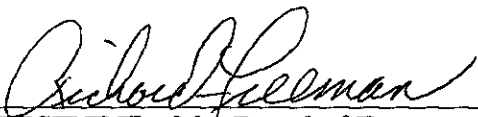

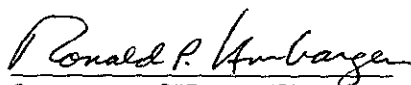
BE IT FURTHER ORDAINED by the Board of Trustees of the Homer Fire Protection District as follows:

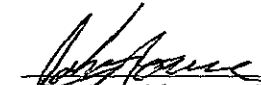
