ORDINANCE 2007 - 2
ANNUAL BUDGET AND APPROPRIATION ORDINANCE FOR THE FISCAL
YEAR BEGINNING THE 1ST DAY OF JULY 2007 AND ENDING
THE 30TH DAY OF JUNE 2008

WHEREAS, The Board of Trustees of the Mahomet Public Library District, Champaign County, Illinois, has prepared or caused to be prepared a tentative form of the Annual Budget and Appropriation for said Library District for the fiscal year beginning July 1, 2007 and ending June 30, 2008 and the same has been conveniently available for public inspection for at least thirty (30) days prior to final action thereon; and

WHEREAS, a public hearing was held as to such Annual Budget and Appropriation Ordinance on August 13, 2007, notice of which was given at least thirty (30) days prior thereto; and

WHEREAS, all other legal requirements have been duly complied with by the Board of Trustees of the Mahomet Public Library District;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE MAHOMET PUBLIC LIBRARY DISTRICT, IN THE COUNTY OF CHAMPAIGN AND STATE OF ILLINOIS, AS FOLLOWS:

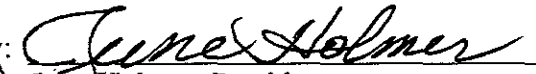

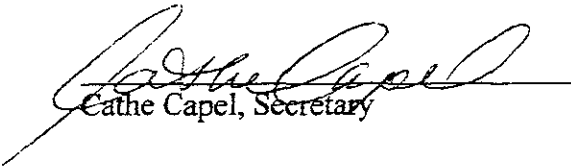
SECTION 5: This Ordinance shall be in full force and effect after its passage, approval and publication as provided by law.

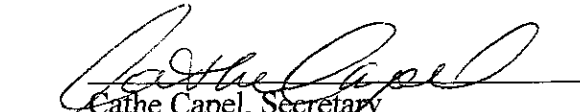

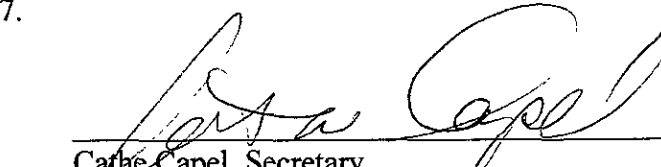
