COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE
IN AND FOR THE PESOTUM FIRE PROTECTION DISTRICT IN THE
COUNTY OF CHAMPAIGN AND STATE OF ILLINOIS AND THE COUNTY
OF DOUGLAS AND STATE OF ILLINOIS FOR THE FISCAL YEAR
BEGINNING MAY 1, 2007 to APRIL 30, 2008, BOTH INCLUSIVE

Be it ordained by the Board of Trustees of the Pesotum Fire Protec-
tion District:

SECTION 1: That this bill be and the same is hereby termed for
"Combined Annual Budget and Appropriation Ordinance in and for the Pesotum
Fire Protection District in the County of Champaign and State of Illinois and
County of Douglas and State of Illinois for the fiscal year beginning May 1,
2007 to April 30, 2008, both inclusive."

SECTION 2: That the following budget containing an estimate of
revenues and expenditures be and the same is hereby adopted as the Budget and
Appropriation Ordinance for the Pesotum Fire Protection District for the
fiscal year beginning May 1, 2007 to April 30, 2008, inclusive.



SECTION 3: That warrants against and in anticipation of the above amounts for the payment of the ordinary and necessary expenses of said District are hereby authorized to be drawn by the president and secretary of the Board of Trustees of said Fire Protection District to the extent of 75% of the amount appropriated herein, in accordance with the statutes in such cases made and provided.



SECTION 5: This Ordinance shall be in full force and effect from and after its passage, adoption, approval and publication in accordance with the law and all ordinances or parts of ordinances in conflict with the provisions of this Ordinance are hereby repealed.


