**ANNUAL BUDGET AND APPROPRIATION ORDINANCE

PHILO FIRE PROTECTION DISTRICT,

An Ordinance making appropriations for the corporate purposes of the PHILO FIRE PROTECTION DISTRICT OF CHAMPAIGN COUNTY, ILLINOIS, for the fiscal year commencing on the first day of January, 2007, and ending on December 31, 2007.

BE IT ORDAINED by the Board of Trustees of the PHILO FIRE PROTECTION DISTRICT, CHAMPAIGN COUNTY, ILLINOIS:

**SECTION 1:**

That the following sums, or so much thereof as may be authorized by law, be and the same are hereby appropriated for the purposes of the PHILO FIRE PROTECTION DISTRICT, to defray all necessary expenses and liabilities of said District as hereinafter specified for the fiscal year commencing on the first day of January, 2007, and ending on December 31, 2007, to-wit:

**SECTION 2**


