ORDINANCE NO. 114

BE IT ORDAINED BY THE CEMETERY TRUSTEES of the Town of Sidney, in the County of Champaign and State of Illinois, that there is hereby adopted for the revenue year 2008 of the said organization, beginning May 1, 2008, this Combined Annual Budget and Appropriation Ordinance for the uses and purposes of said Cemetery Trustees for the control and maintenance of the Cemeteries of said Township, and the maintenance of public cemeteries not operated for profit, in said Township:

which several amount hereinabove itemized aggregating \$10,395.00, have, by said Board of Trustees, been found to be necessary amounts required to be appropriated for the object and purposes of the Cemetery Trustees of the Town of Sidney, Champaign County, Illinois, as so totaled, are hereby appropriated for the purposes aforesaid for said fiscal year to be realized out of taxes to be levied on all of the taxable property within said Town, which tax shall be collected in like manner with other general taxes in such Town, and shall be known as "The Township Cemetery Fund".

This Ordinance shall be made conveniently available for public inspection for a least 30 days prior to final action thereon and a public hearing shall be held as to such Budget and Appropriation Ordinance prior to final action thereon, in the Town Hall, in the Village of Sidney, Illinois, within said Town, on the 11th day of June 2007, beginning at the hour of 7:15 p.m., and a notice of said hearing shall be given by publication in a newspaper of general circulation in the Town of Sidney at least 30 days prior to such hearing, and it shall be the duty of the Secretary of such Trustees to make this Budget and Appropriation Ordinance available for public inspection, and to arrange for such public hearing.




