The Annual Financial Report of the Commissioners of said district, was presented to the Court, and the Court having received no objections from any owner of land in the district, and, having examined the records and files and being fully advised in the premises, DOTH FIND:


1. That the Court has jurisdiction over the subject matter of these proceedings and over the lands and other property in said district.
2. That the verified Annual Financial Report of the Commissioners of said district covering the period from October 1, 2005 to the close of business September 30, 2006, was duly filed with Clerk of this Court on the 21st day of December, 2006.
3. That thereafter, the Clerk of this Court gave due notice of filing of the Report by publication in the form and for the length of time prescribed by statute.
4. That said publication of the Drainage Notice of the Commissioners was on December 28, 2006.
5. That upon the filing of said Report; the same was presented to the Court, to be approved by the Court without a hearing if no objections were filed by any owner of land in the district within ten (10) days of the publication of the Drainage Notice of the Commissioners.
6. That no objections were filed by any owner of land in the district within ten (10) days of the publication of the Drainage Notice of the Commissioners.

7. That all persons interested in said lands and other property, whether as the owners thereof or otherwise, are bound by these proceedings.
8. That said Annual Financial Report of the Commissioners should be approved.
