**ANNUAL TOWNSHIP TAX LEVY ORDINANCE 2004**

An ordinance levying taxes for all town purposes for Colfax Township, Champaign County, Illinois, for the tax year 2004 collectable in 2005.

BE IT ORDAINED by the Board of Trustees of Colfax Township, Champaign County, Illinois, as follows:

SECTION 1: That the sum of Forty-Seven Thousand Two Hundred Ninety-Six and 68/100 Dollars (\$47,296.68) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

BE IT ORDAINED by the Board of Trustees of Colfax Township, Champaign County, Illinois, as follows:


