An Ordinance levying taxes for all town purposes for **COMPROMISE** Township, Champaign County, State of Illinois for the tax year 2004, collectible in 2005.

Be it **ORDAINED** by the Board of Trustees of **COMPROMISE** Township, Champaign County, Illinois, as follows:

Section 1: That the sum of **\$94,500.00** are hereby levied upon all property subject to taxation within the township as that property is assessed and equalized for the current year, in order to meet and defray all the necessary expenses and liabilities of the township as required by statute or voted by the people in accordance with the law, for such purposes as:

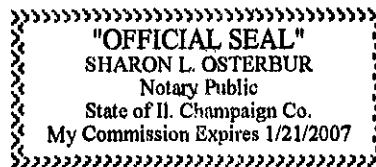

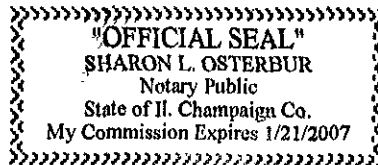
