ANNUAL TAX LEVY ORDINANCE OF THE CORNBELT FIRE PROTECTION DISTRICT

An ordinance for the Levy of Taxes for the fiscal year beginning May 1, 2005 and ending April 30, 2006 for the CORNBELT FIRE PROTECTION DISTRICT of Champaign County, Illinois:

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the CORNBELT FIRE PROTECTION DISTRICT:

SECTION I: LEVY: That there be, and there is hereby, levied at the rate of Thirty-Five Hundredths Percent (.35%) of the value of all property within the corporate limits of said CORNBELT FIRE PROTECTION DISTRICT, subject to taxation the total sum of Five Hundred Thirty-two Thousand, Seven Hundred Sixty-Two dollars and 00/100 (\$532,762) for the following specific purposes mentioned in said Levy Ordinance in the respective sums as follows, to wit:

SECTION II: That this Ordinance shall take effect from and after its passage and approval, as provided by law.



TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of Cornbelt Five Protection District, (Legal Name of Taxing District), and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

Check One of the Choices Below:

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the "Truth in Taxation Law."
- 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- 3) The *proposed* aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The *adopted* aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the "Truth in Taxation Law."
- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the "Truth in Taxation Law."
