**AN ORDINANCE LEVYING TAXES FOR
IVESDALE FIRE PROTECTION DISTRICT FOR FISCAL YEAR 2004-2005**

WHEREAS, the Combined Annual Budget and Appropriations Ordinance for Fiscal Year 2004-2005 has been adopted by the Ivesdale Fire Protection District at a public meeting held on June 29, 2004; and

WHEREAS, it is necessary for the operation of the Ivesdale Fire Protection District that taxes be levied upon all taxable property subject to tax within the boundaries of the Ivesdale Fire Protection District;

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED BY THE IVESDALE FIRE PROTECTION DISTRICT AS FOLLOWS:

Section 1. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Ivesdale Fire Protection District the total sum of \$53,435.72 for the following general purposes:

Section 2. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Ivesdale Fire Protection District the total sum of ~~\$4,200.00~~ for purposes of meeting the annual actuarial requirements of the firefighters' pension fund, which sum is levied in addition to all other taxes now or hereafter authorized to be levied upon all property within the Ivesdale Fire Protection District, and in addition to the amount authorized to be levied for general purposes, under 70 ILCS 705/14.

Section 3. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Ivesdale Fire Protection District the total sum of \$3,200.00 for purposes of meeting the Social Security contributions of the Ivesdale Fire Protection District, which sum is levied in addition to all other taxes now or hereafter authorized to be levied upon all property within

the Ivesdale Fire Protection District, and in addition to the amount authorized to be levied for general purposes, under 70 ILCS 705/14.

Section 4. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Ivesdale Fire Protection District the total sum of \$13,000.00 for purposes of paying liability insurance premiums pursuant to 745 ILCS 10/9-107, which sum is levied in addition to all other taxes now or hereafter authorized to be levied upon all property within the Ivesdale Fire Protection District, and in addition to the amount authorized to be levied for general purposes, under 70 ILCS 705/14.

Section 5. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Ivesdale Fire Protection District the total sum of \$1,500.00 for purposes of paying annual audit expenses pursuant to 65 ILCS 5/8-8-8, which sum is levied in addition to all other taxes now or hereafter authorized to be levied upon all property within the Ivesdale Fire Protection District, and in addition to the amount authorized to be levied for general purposes, under 65 ILCS 5/8-3-1.

Section 6. That the following is a recapitulation of all taxes levied by the Ivesdale Fire Protection District in Sections 1 through 5 hereinabove:

Section 7. That the Secretary of the Board of Trustees is hereby authorized and directed to file a certified copy of this Ordinance with the County Clerks of Champaign and Piatt Counties, Illinois.

Section 8. That this Ordinance shall be known as "An Ordinance Levying Taxes for Ivesdale Fire Protection District for the Fiscal Year 2004-2005, Ordinance No. 04-12-1".

Section 9. That any accumulation of funds is being made pursuant to the provisions of 70 ILCS 705/14, for the purpose of procuring firefighting apparatus and equipment and repairing and improving District buildings.

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.

The adopted aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the Truth in Taxation Law.
- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Law.


