Ordinance No. 04-03

ORDINANCE LEVYING AND ASSESSING TAX FOR MOYER DISTRICT LIBRARY OF THE COUNTIES OF FORD, LIVINGSTON, McLEAN AND CHAMPAIGN, STATE OF ILLINOIS FOR THE FISCAL YEAR BEGINNING THE 1ST DAY OF JULY, 2004 AND ENDING THE 30TH DAY OF JUNE 2005

WHEREAS, the President and Board of Trustees of the Moyer District Library, in the Counties of Ford, Livingston, McLean and Champaign and State of Illinois, did on the 11th day of August, 2004 pass the Annual Budget and Appropriation Ordinance (Ordinance No. 04-02) for said Library District for the fiscal year commencing on July 1, 2004 and ending June 30, 2005; and

WHEREAS, said Annual Budget and Appropriation Ordinance was duly published as provided by law after its passage;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE MOYER DISTRICT LIBRARY, IN THE COUNTIES OF FORD, LIVINGSTON, McLEAN AND CHAMPAIGN AND STATE OF ILLINOIS, as follows:

Section 1: That the total sum of ONE HUNDRED AND FIFTY THOUSAND AND THREE HUNDRED AND SIXTY DOLLARS (\$150360.00) composed as follows: The sum of ONE HUNDRED THIRTY-ONE THOUSAND ONE HUNDRED AND SIXTY DOLLARS (~~\$131,160.00~~) being the amount deemed required for the necessary corporate purposes of Moyer District Library, Ford, Livingston, McLean and Champaign County, Illinois; the sum of FOUR THOUSAND DOLLARS (~~\$4,000.00~~) being required for the payment of employer contributions of Moyer District Library to the Social Security Fund; the sum of TWO THOUSAND SEVEN HUNDRED AND FIFTY DOLLARS (~~\$2,750.00~~) being required for the payment of employer contributions of Moyer District Library to the Illinois Municipal Retirement Fund; the sum of ONE THOUSAND DOLLARS (~~\$1,000.00~~), being required for the payment of

an accountant and other auditing expenses from an ~~Audit Fund~~; the sum of ELEVEN THOUSAND FOUR HUNDRED AND FIFTY DOLLARS (\$11,450.00) for the purpose of payments of premiums due for the purchase of ~~liability insurance~~, Worker's Compensation, unemployment insurance, property damage (fire) insurance and legal fees for defending or otherwise protecting itself against liability from a Liability Fund, be and the same is hereby levied and assessed upon and against all taxable property within this Library District according to the full fair value as established and ascertained for State and County purposes for the fiscal year beginning July 1, 2004 and ending June 30, 2005 and the Board of Trustees of the Moyer District Library having on the 11th day of August, 2004 duly passed and adopted the Annual Budget and Appropriation Ordinance for the fiscal year beginning July 1, 2004 and ending June 30, 2005 and said Ordinance having been duly published in a newspaper of general circulation within this Library District, this Board finds that the specific purposes and the specific amounts provided for in said Annual Budget and Appropriation Ordinance, a copy of which is attached hereto and by this reference made a part hereof, are required to be levied for the necessary purposes of the Moyer District Library.

Section 2: The Secretary of the Board of Trustees of Moyer District Library is hereby directed to file duly certified copies of this Ordinance with the County Clerks of Ford, Livingston, McLean and Champaign Counties, Illinois, in accordance with the laws of the State of Illinois, on or before the last Tuesday of December 2004; and said County Clerks are hereby authorized and directed to extend the said tax so levied by this Ordinance, according to law, against all taxable property within the Moyer District Library. The Secretary of Moyer District Library shall also file on or before the last Tuesday of December 2004, duly certified copies of the Annual Budget and Appropriation Ordinance and this Ordinance with the Moyer District Library where they shall be available for public inspection as provided by law.


Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

**TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE
ALL COUNTIES EXCEPT COOK**

Note: The following certificate is only a suggested format. The county clerk may require a different certificate to be signed by the presiding officer of the taxing district certifying compliance with the Truth in Taxation law or that the law is inapplicable.

I, the undersigned, hereby certify that I am the presiding officer of Moyer District
Library, (Legal Name of Taxing District), and as such presiding
officer I certify that the levy ordinance, a copy of which is attached, was adopted
pursuant to, and in all respects in compliance with the provisions of Section 18-60
through 18-85 of the "Truth in Taxation" law.

Check one of the choices below:

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- 3) The proposed aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The adopted aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the Truth in Taxation Law.
- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Law.
