**AN ORDINANCE LEVYING TAXES FOR
NORTHERN PIATT FIRE PROTECTION DISTRICT
FOR FISCAL YEAR 2004-2005**

WHEREAS, the Combined Annual Budget and Appropriations Ordinance for Fiscal Year 2004-2005 has been adopted by the Northern Piatt Fire Protection District at a public meeting held on July 28, 2004; and

WHEREAS, it is necessary for the operation of the Northern Piatt Fire Protection District that taxes be levied upon all taxable property subject to tax within the boundaries of the Northern Piatt Fire Protection District;

**NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED BY THE
NORTHERN PIATT FIRE PROTECTION DISTRICT AS FOLLOWS:**

Section 1. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Northern Piatt Fire Protection District the total sum of \$88,700.00 for the following purposes:

Section 3. That this Ordinance shall be known as "An Ordinance Levying Taxes for Northern Piatt Fire Protection District for the Fiscal Year 2004-2005, Ordinance No. 2004-___".


Section 4. That any accumulation of funds is being made pursuant to the provisions of 70 ILCS 705/14, for the purpose of procuring firefighting apparatus and equipment and repairing and improving District buildings.

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of the Northern Piatt Fire Protection District, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with, the provisions of Sections 18-60 through 18-85 of the "Truth in Taxation" law.


