An ordinance levying taxes for all town purposes for Pesotum Township,  
Champaign County, Illinois, for the tax year 2004 , collectable in 2005.

BE IT ORDAINED by the Board of Trustees of Pesotum Township,  
Champaign County, Illinois, as follows:

SECTION 1: That the sum of Fifty-two thousand nine hundred thirty-three Dollars  
(\$52, 933.00) are hereby levied upon all  
property subject to taxation within the Township as that property is assessed and equalized, in order to  
meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted  
by the people in accordance with the law, for such purposes as:
