**LEVY ORDINANCE OF CEMETERY**  
**TRUSTEES OF THE TOWN OF SIDNEY IN THE COUNTY**  
**OF CHAMPAIGN AND STATE OF ILLINOIS FOR THE**  
**REVENUE YEAR 2005**  
**ORDINANCE NO. 109**

BE IT ORDAINED BY THE CEMETERY TRUSTEES OF THE TOWN OF SIDNEY IN THE COUNTY OF CHAMPAIGN AND STATE OF ILLINOIS that there is hereby adopted for the Revenue Year 2005, beginning May 1, 2005, of said organization for the uses, purposes and requirements of said Cemetery Trustees for the following uses and purposes:

For insurance - Worker's Compensation-----	\$ -0-
For road construction and repairs-----	\$ 140.00
For publishing expense-----	\$ 175.00
For legal expense-----	\$ 500.00
For filling and grading cemetery-----	\$ 400.00
For labor and maintenance of cemetery-----	\$ 4,000.00
For maintenance of Mt. Hope cemetery-----	\$ 4,000.00
For Trustees' salaries-----	\$ 450.00
For Liability Insurance-----	\$ 220.00
For Postage, supplies and typing-----	\$ 100.00
For Social Security-----	\$ 100.00
For Drainage-----	\$ 10.00
For Treasurer's Salary-----	\$ 300.00

which several amount hereinabove itemized aggregation Ten Thousand Three Hundred Ninety Five DOLLARS (\$10,395.00), by said Board of Trustees, which amount has been found to be necessary and required to be levied for the objects and purposes of the Cemetery Trustees of the Town of Sidney, and which aggregate amount is hereby levied to be realized out of the taxes on all the taxable property within said Town, which tax shall be collected in like manner with other general taxes in such Town, and shall be known as "The Township Cemetery Fund."

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of the Sidney Cemetery District, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

Check one of the choices below:

1. The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the "Truth in Taxation" law.
2. The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
3. The *proposed* aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The *adopted* aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the "Truth in Taxation" law.
4. The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the "Truth in Taxation" law.
