WHEREAS, the Board of Trustees of the Village of Foosland in the County of Champaign and State of Illinois, did on the 12th day of April A. D. 192004 pass the annual appropriation bill for said Village for the fiscal year beginning on the 1st day of May A. D. 192004 the amount of which is ascertained to be the aggregate sum of \$34,000.00 Dollars, which said appropriation bill was duly posted on the 15th day of April A. D. 192004 Now, therefore

AN ORDINANCE FOR THE LEVY AND ASSESSMENT OF TAXES FOR THE CURRENT FISCAL YEAR

BE IT ORDAINED by the Board of Trustees of the Village of Foosland Illinois:

Section 1. That there be and is hereby levied upon all the taxable property within the corporate limits of said Village of Foosland subject to taxation for the year, A. D. 192004,

the total sum of 1472.04 Dollars, for the following specific purposes mentioned in said appropriation bill and in the respective sums as follows, to-wit:

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of Village of

certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all
respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in
