

ORDINANCE NO. 267 - Levy

WHEREAS, the Board of Trustees of the Village of Gifford, Illinois, did on the 28th day of October, 2004, pass an Annual Appropriation Ordinance for the Village for the fiscal year beginning on the 1st day of May, 2004, the aggregate amount of which is ascertained to be in the sum of SIX HUNDRED EIGHT THOUSAND FIVE HUNDRED FIFTY-FIVE AND NO/HUNDREDTHS DOLLARS (\$608,555.00).

SECTION 1. Now, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF GIFFORD, ILLINOIS, that there be and is hereby levied upon all of the taxable property within the corporate limits of the Village of Gifford, Illinois, for the fiscal year beginning May 1, 2004 and ending April 30, 2005, the sum of FIFTY-FIVE THOUSAND FOUR HUNDRED AND TWO AND NO/HUNDREDTHS DOLLARS (\$55,402.00) for the following specific purposes mentioned in said Appropriation Ordinance in the following sums:



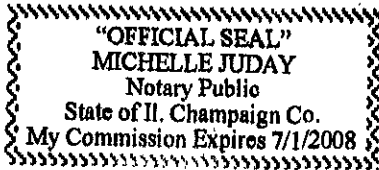
