ORDINANCE NO. 520

ANNUAL TAX LEVY ORDINANCE

WHEREAS, the President and Board of Trustees of the Village of Thomasboro in the County of Champaign, State of Illinois, did on the 6th day of July 2004, pass the Annual Appropriation Bill for said Village for the fiscal year beginning on the 1st day of May, 2004, and ending on the 30th day of April, 2005, the amount of which is ascertained to be the aggregate sum of \$1,040,000.00, which Appropriation Ordinance was duly published by pamphlet form by authority of the Board of Trustees.

SECTION I

That there be and there is hereby levied upon all taxable property within the corporate limits of the Village of Thomasboro, Illinois, subject to taxation for the year beginning May 1, 2004, and ending April 30, 2005, the total sum of \$64,200.00 for the following specific purposes mentioned in said Appropriation Ordinance and in the respective sums as follows:

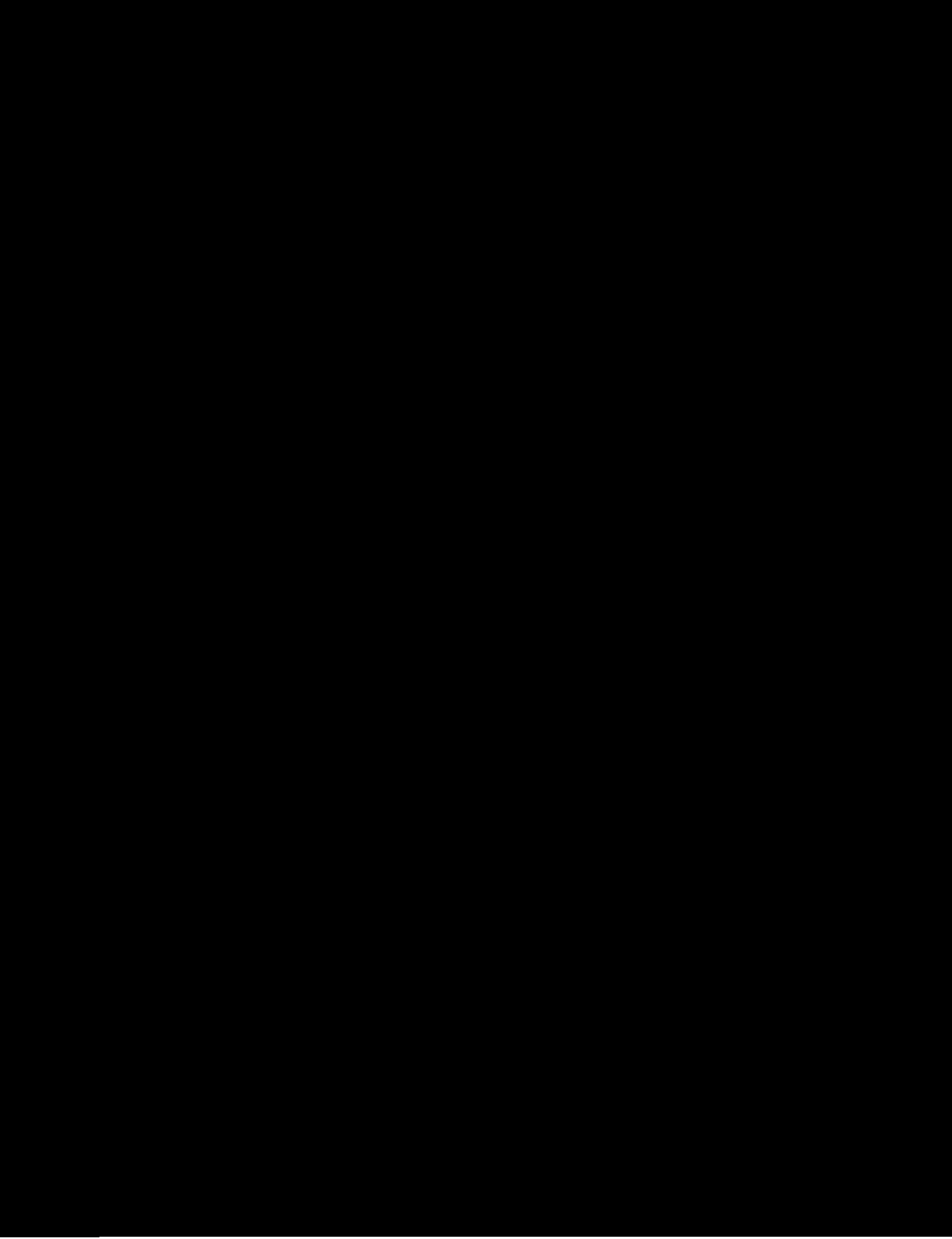

All such sums so levied shall be in addition to all other taxes levied and collected in the Village of Thomasboro and shall be in addition to the maximum tax permitted to be levied under Section 8-3-1 of the Illinois Municipal Code (65 ILCS 5/8-3-1). The County Clerk extending the tax levy for these special purposes shall not consider the tax herein authorized as part of the general tax levied for the Village of Thomasboro and shall not include the same in the limitation upon the assessed valuation upon which taxes are required to be extended as provided by law.



in pamphlet form.


SECTION XII
