

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE NO. 06-4

An ordinance levying taxes for all town purposes for Condit Township, Champaign County, Illinois, for the tax year 2006, collectable in 2007.

BE IT ORDAINED by the Board of Trustees of Condit Township, Champaign County, Illinois, as follows:

SECTION 1: That the sum of Thirty-four thousand six hundred two and 00/100 Dollars (\$34,602.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:



ORDINANCE NO. 06-5

An ordinance levying taxes for all road purposes for Condit Road District, Champaign County, Illinois, for the tax year 2006, collectable in 2007.

BE IT ORDAINED by the Board of Trustees of Condit Township, Champaign County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of Condit Road District on December 11, 2006, does hereby determine and declare that the sum of Seventy-nine thousand three hundred twenty-two and 00/100 Dollars (\$79,322.00) is hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:
