**ANNUAL TAX LEVY ORDINANCE OF THE CORNBELT FIRE PROTECTION DISTRICT**

An ordinance for the Levy of Taxes for the fiscal year beginning May 1, 2007 and ending April 30, 2008 for the CORNBELT FIRE PROTECTION DISTRICT of Champaign County, Illinois:

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the CORNBELT FIRE PROTECTION DISTRICT:

**SECTION 1: LEVY:** That there be, and there is hereby, levied at the rate of Thirty-Five Hundredths Percent (.35%) of the value of all property within the corporate limits of said CORNBELT FIRE PROTECTION DISTRICT, subject to taxation the total sum of Eight Hundred Thirty Thousand, Eight hundred and Four dollars and 00/100 (\$742,642) for the following specific purposes mentioned in said Levy Ordinance in the respective sums as follows, to wit:





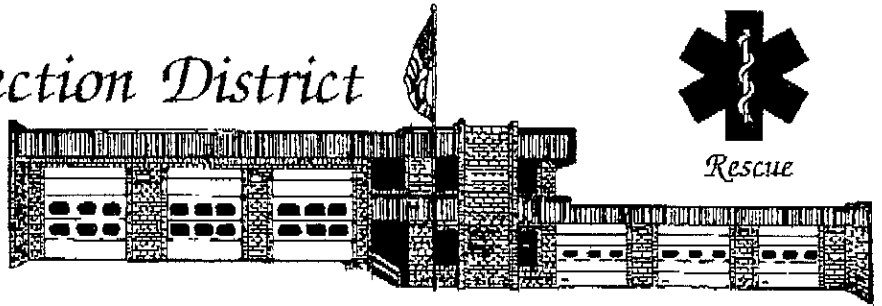

A public hearing to approve a proposed property tax levy increase for the Cornbelt Fire Protection District for 2007-2008 will be held on November 1, 2006 at 7:00 pm at the Fire Station at 506 East Main Street, Mahomet, Illinois. II. The corporate and special purpose property taxes extended for 2006-2007 were \$573,597. The proposed corporate and special purpose property taxes to be levied for 2007-2008 are \$742,642. This represents a 29% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2007-2008 were \$-0-. The estimated property taxes to be levied for debt service and public building commission leases for 2007-2008 are \$-0-. This represents a 0% increase over the previous year.

IV. The total property taxes extended for 2006-2007 were \$573,597. The estimated total property taxes to be levied for 2007-2008 are \$742,642. This represents a 29% increase over the previous year.

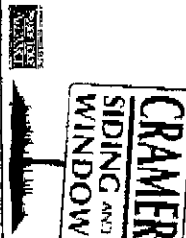

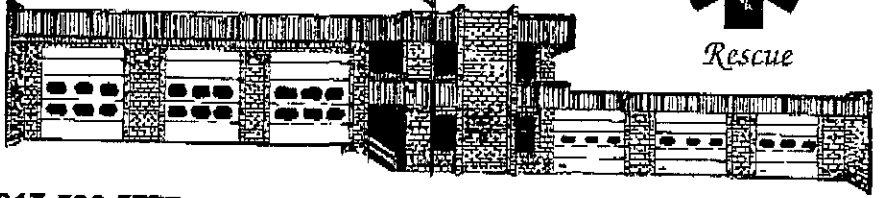
