

ORDINANCE NO 125

TAX LEVY ORDINANCE OF GIFFORD FIRE PROTECTION
DISTRICT FOR THE REVENUE YEAR 2006

BE IT ORDAINED by the Board of Trustees of GIFFORD FIRE PROTECTION DISTRICT, in Champaign County, State of Illinois:

Section 1: That the sum of \$105,400.00 is hereby levied upon all property subject to taxation within the GIFFORD FIRE PROTECTION DISTRICT as that property is assessed and equalized for the current year, in order to meet and defray all the necessary expenses and liabilities of the District as required by statute or voted by the people in accordance with the law, for such purposes as:

- A. GENERAL FUND
- B. LIABILITY FUND
- C. AUDIT FUND

Section 2: That the amount levied for each such object and purpose shall be as follows:
