ORDINANCE NO. 06-11-1

**AN ORDINANCE LEVYING TAXES FOR
THE VILLAGE OF IVESDALE FOR FISCAL YEAR 2006-2007**

WHEREAS, the Annual Appropriation Ordinance No. 06-7-1 has been adopted by the Board of Trustees of the Village of Ivesdale at a public meeting held on July 17, 2006; and

WHEREAS, it is necessary for the operation of the Village of Ivesdale that taxes be levied upon all taxable property subject to tax within the boundaries of the Village of Ivesdale;

NOW, THEREFORE, BE IT AND IT IS HEREBY ORDAINED BY THE BOARD OF TRUSTEES OF THE VILLAGE OF IVESDALE AS FOLLOWS:

Section 1. GENERAL FUND. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Village of Ivesdale the total sum of \$7,390.00 for the following general purposes:

Section 2. POLICE PROTECTION FUND. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Village of Ivesdale the total sum of \$2,307.00 for purposes of police protection and law enforcement, which sum is levied pursuant to the provisions of 65 ILCS 5/11-1-3.

Section 3. ESDA. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Village of Ivesdale the total sum of ~~\$72.00~~^{cut to 70 ✓} for purposes of purchasing and maintaining emergency medical technician supplies, which sum is levied pursuant to the provisions of 65 ILCS 5/8-3-16.

Section 4. MUNICIPAL TORT IMMUNITY FUND. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Village of Ivesdale the total sum of \$2,500.00 for purposes of paying liability insurance premiums pursuant to 745 ILCS 10/9-107, which sum is levied in addition to all other taxes now or hereafter authorized to be levied upon all property within the Village of Ivesdale, and in addition to the amount authorized to be levied for general purposes, under 65 ILCS 5/8-3-1.

Section 5. AUDIT FUND. That there be and hereby is levied upon all taxable property subject to tax within the boundaries of the Village of Ivesdale the total sum of \$2,500.00 for

purposes of paying annual audit expenses pursuant to 65 ILCS 5/8-8-8, which sum is levied in addition to all other taxes now or hereafter authorized to be levied upon all property within the Village of Ivesdale, and in addition to the amount authorized to be levied for general purposes, under 65 ILCS 5/8-3-1.

Section 6. RECAPITULATION. That the following is a recapitulation of all taxes levied by the Village of Ivesdale in Sections 1 through 5 hereinabove:

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of the Village of Ivesdale, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with, the provisions of Sections 18-60 through 18-85 of the "Truth in Taxation" law.

Check One of the Choices Below

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
