LINCOLNSHIRE FIELDS FIRE PROTECTION DISTRICT



A certified copy of this Ordinance shall be filed with the County Clerk of Champaign County, Illinois, within the time specified by law.


This Ordinance shall be in full force and effect from and after its passage and approval.



TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of Lincolnshire Fields Fire Protection District, (Legal Name of Taxing District), and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the "Truth in Taxation Law".
