BE IT ORDAINED BY THE MAYOR AND THE VILLAGE BOARD OF THE  
VILLAGE OF LUDLOW, ILLINOIS, as follows:

WHEREAS, the current fiscal year of the Village of Ludlow, Champaign County, Illinois, begins April 1, 2006 and ends on March 31, 2007, and the said Village has adopted its Budget and Appropriation Ordinance, which was duly published and filed with the County Clerk.

AND WHEREAS, said Budget and Appropriation Ordinance appropriated a total amount of money in the amount of Ninety Six Thousand Six Hundred and No/100 Dollars (\$96,600.00), all as detailed and set forth therein.

NOW THERREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE

There is hereby levied in the aggregate, a general tax upon all the taxable property within the Village of Ludlow, Champaign County, Illinois, as the same is assessed and equalized for State and County purposes for the year 2006 to be levied and assessed in the year 2007, the aggregate sum of Six Thousand Five Hundred Fifteen and No/100 Dollars (\$6,515.00), comprised as follows:

a. For general corporate purposes, the sum of Five Thousand Seventy One and No/100 Dollars (\$5,071.00).

b. There is further levied, in addition to all other taxes levied for general purposes the amount of Five Hundred and No/100 Dollars (\$500.00) for auditing.

c. There is further levied, in addition to all other taxes levied for general purposes the amount of Seven Hundred Sixty Seven and No/100 Dollars (\$767.00) for police protection.

d. There is further levied, in addition to all other taxes levied for general purposes the amount of One Hundred Fifty Seven and No/100 Dollars (\$157.00) for garbage collection.

e. There is further levied, in addition to all other taxes levied for general purposes the amount of Twenty and No/100 Dollars (\$20.00) for ESDA.

Section 2. This Ordinance shall be effective upon its passage.

Section 3. The Secretary of the Board of Trustees is directed to file a certified copy of this Ordinance with the County Clerk of Champaign County, Illinois.

This Ordinance is hereby passed by the affirmative vote, the "Ayes" and "Nays" being called, of a majority of the members of the Board of Trustees of the Village of Ludlow at a duly called regular meeting of the said Board of Trustees on the 2<sup>nd</sup> day of October, 2006.

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of the Village of Ludlow, Illinois, and as such presiding officer I certify that the Levy Ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.
