Ordinance No. 06-03

ORDINANCE LEVYING AND ASSESSING TAX FOR MOYER  
DISTRICT LIBRARY OF THE COUNTIES OF FORD, LIVINGSTON, McLEAN  
AND CHAMPAIGN, STATE OF ILLINOIS FOR THE FISCAL YEAR BEGINNING  
THE 1ST DAY OF JULY, 2006 AND ENDING  
THE 30th DAY OF JUNE, 2007

WHEREAS, the President and Board of Trustees of the Moyer District Library, in the Counties of Ford, Livingston, McLean and Champaign and State of Illinois, did on the 9 day of August, 2006 pass the Annual Budget and Appropriation Ordinance (Ordinance No. 06-02) for said Library District for the fiscal year commencing on July 1, 2006 and ending June 30, 2007; and

WHEREAS, said Annual Budget and Appropriation Ordinance was duly published as provided by law after its passage;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE MOYER DISTRICT LIBRARY, IN THE COUNTIES OF FORD, LIVINGSTON, McLEAN AND CHAMPAIGN AND STATE OF ILLINOIS, as follows:

Section 1: That the total sum of ONE HUNDRED FIFTY-FIVE THOUSAND SEVEN HUNDRED FIFTY DOLLARS (\$155,750.00) composed as follows: The sum of ONE HUNDRED TWENTY THOUSAND DOLLARS (\$120,000.00), being the amount deemed required for the necessary corporate purposes of Moyer District Library, Ford, Livingston, McLean and Champaign County, Illinois; the sum of FOUR THOUSAND TWO HUNDRED FIFTY DOLLARS (\$4,250.00), being required for the payment of employer contributions of Moyer District Library to the Social Security Fund; the sum of THREE THOUSAND DOLLARS (\$3,000.00), being required for the payment of employer contributions of Moyer District Library to the Illinois Municipal Retirement Fund; the sum of ONE THOUSAND DOLLARS (\$1,000.00),

being required for the payment of the professional opinion of an accountant and other auditing expenses from an Audit Fund; the sum of ELEVEN THOUSAND FIVE HUNDRED DOLLARS (\$11,500.00<sup>X</sup>) for the purpose of payments of premiums due for the purchase of liability insurance, Workers' Compensation, unemployment insurance, property damage (fire) insurance and legal fees for defending or otherwise protecting itself against liability from a Liability Fund; the sum of SIXTEEN THOUSAND DOLLARS (\$16,000.00<sup>X</sup>), being required for the maintenance, repairs and alterations of library buildings and equipment from a Maintenance Fund, be and the same is hereby levied and assessed upon and against all taxable property within this Library District according to the full fair value as established and ascertained for State and County purposes for the fiscal year beginning July 1, 2006 and ending June 30, 2007 and the Board of Trustees of the Moyer District Library having on the 9 day of August, 2006 duly passed and adopted the Annual Budget and Appropriation Ordinance for the fiscal year beginning July 1, 2006 and ending June 30, 2007 and said Ordinance having been duly published in a newspaper of general circulation within this Library District, this Board finds that the specific purposes and the specific amounts provided for in said Annual Budget and Appropriation Ordinance, a copy of which is attached hereto and by this reference made a part hereof, are required to be levied for the necessary purposes of the Moyer District Library.


Section 2: The Secretary of the Board of Trustees of Moyer District Library is hereby directed to file duly certified copies of this Ordinance with the County Clerks of Ford, Livingston, McLean and Champaign Counties, Illinois, in accordance with the laws of the State of Illinois, on or before the last Tuesday of December 2006; and said County Clerks are hereby authorized and directed to extend the said tax so levied by this Ordinance, according to law, against all taxable

property within the Moyer District Library. The Secretary of Moyer District Library shall also file on or before the last Tuesday of December 2006, duly certified copies of the Annual Budget and Appropriation Ordinance and this Ordinance with the Moyer District Library where they shall be available for public inspection as provided by law.


Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as provided by law.

# TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Law.

## NOTICE OF PROPOSED PROPERTY TAX INCREASE FOR MOYER DISTRICT LIBRARY

I. A public hearing to approve a proposed property tax levy increase for the Moyer District Library for 2006 will be held on October 11, 2006 at 7:00 P.M. at the Library, 307 N. Sangamon Ave., Gibson City, Illinois.

II. The corporate and special purpose property taxes extended for 2005 were \$136,075.45. The proposed corporate and special purpose property taxes to be levied for 2006 are \$155,750.00. This represents a 14.5% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2005 were 0-.

The estimated property taxes to be levied for debt service and public building commission leases for 2006 are \$0. This represents a 0% increase over the previous year.

IV. The total property taxes extended for 2005 were \$136,075.45

The estimated total property taxes to be levied for 2006 are \$155,750.00. This represents a 14.5% increase over the previous year.

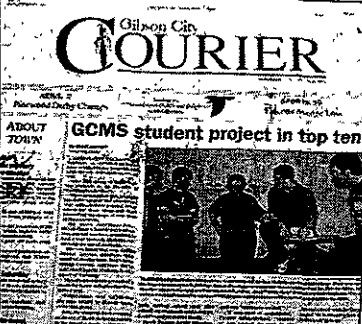
