An ordinance levying taxes for all town purposes for PHILO Township, CHAMPAIGN County, Illinois, for the tax year 2006, collectable in 2007.

BE IT ORDAINED by the Board of Trustees of PHILO Township, CHAMPAIGN County, Illinois, as follows:

SECTION 1: That the sum of Eighty-Eight Thousand Five Hundred Four Dollars and no cents (\$88,504.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

GENERAL ASSISTANCE, AUDIT,

LIABILITY INSURANCE,

for the year 2006.



ORDINANCE NO. 2006-07 Road

An ordinance levying taxes for all road purposes for PHILO Road District, CHAMPAIGN County, Illinois, for the tax year 2006 , collectable in 2007.

BE IT ORDAINED by the Board of Trustees of PHILO Township, CHAMPAIGN County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of PHILO Road District on December 5, 2006 does hereby determine and declare that the sum of Two Hundred Seventy Thousand Four Hundred One Dollars and no Cents (\$270,401.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as:


