ORDINANCE NO. 2006-3

AN ORDINANCE LEVYING AND ASSESSING THE
TAXES OF THE RANTOUL PARK DISTRICT FOR
THE FISCAL YEAR BEGINNING JANUARY 1, 2006
AND ENDING DECEMBER 31, 2006

BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE RANTOUL PARK DISTRICT:

Section 1. That the sum of \$76,000.00 be and the same is hereby assessed and levied from and against all taxable property within the limits of said **RANTOUL PARK DISTRICT**, as the same is assessed and equalized for State and County purposes for the current fiscal year of said Park District commencing January 1, 2006, and ending December 31, 2006, to be applied in liquidation of the appropriations heretofore made by ordinance adopted by the Board of Commissioners of said Park District at a regular meeting thereof convened March 23, 2006:

1. YOUTH CENTER SUPPORT	18,000.00
2. MAPLEWOOD, WABASH PARK MAINTENANCE	
a) Tennis courts electricity	800.00
b) Park fertilizer	2,000.00
c) Land Rent	545.00
d) Grounds, park maintenance	8,200.00
e) Golf course chemicals	27,655.00
f) Treasurer, legal	18,800.00

TOTAL: \$ 76,000.00

Section 2. For the contribution of the Rantoul Park District to the Illinois Municipal Retirement Fund, there is hereby levied and assessed for the Fiscal Year beginning January 1, 2006 and ending December 31, 2006, the sum of \$6,800.00 upon all property subject to taxation with the said District at the full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for State and County purpose as follows:

Payments to the Illinois Municipal Retirement Fund	\$ 6,800.00

Said tax shall be in addition to the several other sums levied and assessed and shall be in addition to all other taxes authorized by law.

Section 3. To provide for the cost to the Rantoul Park District for the payment of premiums due for the purchase of Public Liability insurance, there is hereby levied and assessed for the Fiscal Year beginning January 1, 2006 and ending December 31, 2006, the sum of \$3,800.00 upon all property subject to taxation within the said District at the full, fair cash value as the same is assessed and equalized by the Department of Local government Affairs of the State of Illinois for State and County purposes, as follows:

Payments for the purchase of Public Liability Insurance	\$3,800.00

Said tax shall be in addition to the several other

sums levied and assessed and shall be in addition to all other taxes authorized by law.

Section 4. To provide for the cost to the Rantoul Park District for the purpose of paying for Auditing Expense, there is hereby levied and assessed for the Fiscal Year beginning January 1, 2006 and ending December 31, 2006, the sum of \$1,400.00 upon all property subject to taxation within the said District at the full, fair cash value as the same is assessed and equalized by the Department of Local Government Affairs of the State of Illinois for State and County purposes, as follows:

Payments for Auditing Expense	\$1,400.00


Said tax shall be in addition to the several other sums levied and assessed and shall be in addition to all other taxes authorized by law.

Section 5. That the Secretary is hereby directed to file a certified copy of this Ordinance with the County Clerk of Champaign County within the time specified by law.

Section 6. This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
