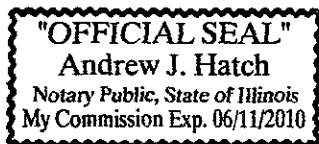

TAX LEVY ORDINANCE OF ROLLING ACRES

FIRE PROTECTION DISTRICT

ORDINANCE NO. 71

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF ROLLING ACRES FIRE PROTECTION DISTRICT that there is required for the Revenue Year 2006, for the financial needs of said District for the following purposes hereto-fore appropriated, to wit:


FOR GENERAL CORPORATE FUND:

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of Rolling Acres Fire Protection District, (Legal Name of Taxing District), and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the "Truth in Taxation Law."
