**WHEREAS:** The Board of Trustees of the Village of Sadorus, County of Champaign and State of Illinois did previously adopt an Annual Appropriation Ordinance; and

**WHEREAS:** The total appropriation of all accounts and funds is \$121,205.00 with receipts of \$15,873.00 anticipated from the within levy and the balance, \$105,332.00 being estimated receipts from other sources; and

**WHEREAS:** Pursuant to a duly held public meeting the Board of Trustees has considered public input and review of the Ordinance and all other matters.

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Sadorus, Champaign County, Illinois:

**SECTION 1:** That the total amount of appropriations for all corporate purposes legally made to be collected from the tax levy of the current fiscal year is hereby ascertained to be the sum of Fifteen Thousand Eight Hundred Seventy Three Dollars and 00/100 (\$15,873.00).

**SECTION 2:** That the sum of Fifteen Thousand Eight Hundred Seventy Three Dollars and 00/100 (\$15,873.00), being the total of appropriations heretofore legally made which are to be collected from the tax levy of the current fiscal year of the Village of Sadorus, for purposes of providing for a Municipal Tort Immunity Fund, Audit Fund, Civil Defense Fund, and Corporate Fund, as appropriated for the current fiscal year by annual appropriation ordinance of the Village of Sadorus for the year 2006-2007, passed by the President and Board of Trustees of said Village and the same is hereby levied upon all of the taxable property in the Village of Sadorus, subject to taxation for the current year, the specific amounts as levied for the various funds heretofore named being included herein. The total of which has been ascertained as aforesaid and being as follows:

**SECTION 3:** That the total amount of Fifteen Thousand Eight Hundred Seventy Three Dollars and 00/100 (\$15,873.00) ascertained as aforesaid be, and the same is hereby levied and assessed on all property subject to taxation within the Village of Sadorus according to the value of said property as the same is assessed and equalized for State and County purposes for the current year.


**SECTION 4:** This levy ordinance is adopted pursuant to the procedures set forth in the Illinois Municipal Code, provided, however, any tax rate limitation or any other substantive limitation as to tax levies in Illinois Municipal code in conflict with this Ordinance shall not be applicable to this Ordinance pursuant to Section 6 Article VII of the Constitution of the State of Illinois. To the extent that any levy amount provided herein exceeds any limitation by law, such levy amount shall be equivalent to the maximum amount allowed by law.

**SECTION 5:** That there is hereby certified to the County Clerk of Champaign County, Illinois, the several sums aforesaid, constituting said total amount and the said total amount of Fifteen Thousand Eight Hundred Seventy Three Dollars and 00/100 (\$15,873.00) which said total amount the said Village of Sadorus requests to be raised by taxation for the current fiscal year of said Village, and Village Clerk of said Village is hereby ordered and directed to file with the County Clerk of said County on or before the time required by law, a certified copy of this Ordinance.


**SECTION 6:** The said several sums of money are hereby appropriated from monies received and to be received by the VILLAGE OF SADORUS from all sources, and nothing set forth herein shall prohibit transfers from one Village fund to another provided such monies are disbursed in compliance with law, this ordinance and subsequent tax levies. In the event that any portion of this ordinance is deemed invalid, the balance of said ordinance shall be given full force and effect to the extent allowed by law.

**SECTION 7:** This Ordinance shall take effect and be in full force and effect immediately on and after its passage and approval.


