AN ORDINANCE FOR THE LEVY OF TAXES FOR THE FISCAL YEAR  
BEGINNING MAY 1, 2006, AND ENDING APRIL 30, 2007, FOR  
SADORUS FIRE PROTECTION DISTRICT IN THE COUNTY OF CHAMPAIGN,  
IN THE STATE OF ILLINOIS

WHEREAS, the Board of Trustees of Sadorus Fire Protection District, of the County of Champaign, in the State of Illinois, have heretofore passed an Annual Appropriation Ordinance:

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of Sadorus Fire Protection District:

SECTION 1: General Fire Fund Levy. That there be and is hereby levied upon all taxable property within the corporate limits of the Sadorus Fire Protection District subject to taxation for the year 2006 the total sum of FIFTY THOUSAND (\$50,000.00) DOLLARS, and request the County Clerk to extend such rate not to exceed .30% as is necessary to produce the total amount herein levied, for the following specific purposes mentioned in the said appropriation ordinance, in the respective amounts as follows:

SECTION 2. Liability Insurance Levy. That there be and is hereby levied upon all taxable property within the corporate limits of the Sadorus Fire Protection District subject to taxation for the year 2006 the total sum of FIVE THOUSAND EIGHT HUNDRED (\$5,800.00) DOLLARS, and request the County Clerk to extend such rate as is necessary to produce the total amount herein levied, for the following specific purposes mentioned in the said appropriation

ordinance, in the respective amounts as follows:

SECTION 3. Audit Levy. That there be and is hereby levied upon all taxable property within the corporate limits of the Sadorus Fire Protection District subject to taxation for the year 2006 the total sum of SEVEN HUNDRED FIFTY (\$750.00) DOLLARS, and request the County Clerk to extend such rate as is necessary to produce the total amount herein levied, for the following specific purposes mentioned in the said appropriation ordinance, in the respective amounts as follows:

SECTION 4. That the above sums, each of them and the aggregate thereof, are deemed necessary by the Board of Trustees of Sadorus Fire Protection District to defray the necessary expenses and liabilities of the said Fire Protection District. In the event that the full amounts for each fund cannot be extended by the Champaign County Clerk, the Sadorus Fire Protection District


directs that the extensions for the levy be abated in the following order: Audit Fund, Liability Insurance Fund, and General Fire Fund Levy.

SECTION 5. That the Secretary of this Board of Trustees is hereby directed to file a certified copy of this Ordinance with County Clerk of the County of Champaign, in the State of Illinois, as is provided by law.

SECTION 6. That it will be necessary for this Fire Protection District to repair and improve the Fire House and to purchase some new fire-fighting equipment and, in order to do so, it is necessary for this Board of Trustees to accumulate funds for that purpose, and that is the reason these Trustees are making a Levy in excess of the current requirements for this District's other purpose. That this accumulation of funds is authorized by 70 ILCS 705/14 of the Illinois Revised Statutes, as amended.

SECTION 7. This Ordinance shall be in full force and effect from and after its passage and approval, in accordance with the law.



I, the undersigned, hereby certify that I am the presiding officer of the **Sadorus Fire Protection District**, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.
- 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
