An ordinance levying taxes for all town purposes for Sadorus Township, Champaign County, Illinois, for the tax year 2006 collectable in 2007.

BE IT ORDAINED by the Board of Trustees of Sadorus Township, Champaign County, Illinois, as follows:

SECTION 1: That the sum of Seventy-six Thousand Nine Hundred Sixty-five Dollars (\$76,965.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:






