ORDINANCE 2006L
ANNUAL TAX LEVY ORDINANCE
OF THE
SCOTT FIRE PROTECTION DISTRICT

An Ordinance for the Levy of Taxes for the fiscal year beginning May 1, 2006 and ending April 30, 2007 for the SCOTT FIRE PROTECTION DISTRICT of Champaign County, Illinois, and Piatt County, Illinois:

WHEREAS, the Board of Trustees of the SCOTT FIRE PROTECTION DISTRICT of Champaign County, Illinois, and Piatt, Illinois did on the 28th day of August, 2006, pass the Annual Budget and Appropriation Ordinance for said District for the fiscal year beginning on May 1, 2006 and ending on the 30th day of April, 2007, the amount of which is ascertained to be in the sum of Ninety Eight Thousand Dollars (\$98,000.00), which ordinance was duly published as provided by law.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the SCOTT FIRE PROTECTION DISTRICT:

SECTION I: LEVY: That there be, and there is hereby, levied at the rate of Twenty-Two Hundredths Percent (.22%) of the value of all property within the corporate limits of said SCOTT FIRE PROTECTION DISTRICT, subject to taxation the total sum of Ninety Eight Thousand Dollars (\$98,000.00) for the following specific purposes mentioned in said Appropriation Ordinance in the respective sums as follows, to wit:




SECTION IV: All Ordinances and Resolutions, or parts thereof, in conflict herewith are hereby repealed.
