ANNUAL TAX LEVY ORDINANCE

An ordinance levying taxes for the Village of St. Joseph, Champaign

County, Illinois, for the fiscal year beginning May 1, 2006 and ending April 30, 2007.

THEREFORE BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES FOR THE VILLAGE OF ST. JOSEPH, CHAMPAIGN COUNTY, ILLINOIS:

SECTION 1: That the sum of THREE MILLION SIX HUNDRED FORTY THOUSAND DOLLARS (3,640,000.00), being the total of the appropriations heretofore legally made, a portion of which are to be collected from the tax levy of the fiscal year of the Village of St. Joseph, Champaign County, Illinois, beginning May 1, 2006 and ending April 30, 2007 for all corporate purposes of said Village, including: GENERAL CORPORATE FUND, SCHOOL CROSS GUARD FUND, POLICE FUND, POLICE IMRF FUND, AUDIT FUND, LIABILITY INSURANCE FUND, STREET LIGHTS FUND, PUBLIC BENEFIT FUND, SOCIAL SECURITY FUND, VILLAGE IMRF, CIVIL DEFENSE (ESDA & RESPONDER), SEWER FUND, as appropriated for said current fiscal year by the ANNUAL APPROPRIATION ORDINANCE of said Village of St. Joseph, for the fiscal year beginning May 1, 2006 and ending April 30, 2007, passed by the Village Board of said Village of St. Joseph, at its regular meeting held the 27th of JUNE 2006 , AND THE SAME IS HEREBY LEVIED on all taxable property within the said Village of St. Joseph, subject to taxation for said current fiscal year. The specific amounts as levied for the various objects heretofore named appear in the middle column under the designation, "AMOUNT TO BE RAISED BY TAXATION", the said tax so levied being for appropriations heretofore made for said current fiscal year which are to be collected from said tax levy, the total amount of which has been ascertained as aforesaid for the objects and purposes as follows:


SECTION 2: That the Village Clerk shall make and file with the County Clerk of said County of Champaign, a duly certified copy of this ordinance and that the amount levied by Section 1 of the Ordinance is required by said Village to be levied by taxation as aforesaid and extended upon the appropriate tax books for the fiscal year of said Village beginning May 1, 2006 and ending April 30, 2007.

SECTION 3: That any amounts shown "To Be Raised by Taxation" which exceed the amount allowed by law to be raised by taxation shall be raised by other sources.

SECTION 4: If any section, subdivision, sentence or clause of this Ordinance is for any reason held invalid or to be unconstitutional, such decision shall not affect the validity of the remaining portion of the Ordinance.

SECTION 5: This Ordinance shall be in full force and effect from and after its passage, approval, and recording, according to law.



**NOTICE OF PROPOSED PROPERTY TAX INCREASE
FOR THE VILLAGE OF ST. JOSEPH,

- I. A public hearing to approve a proposed property tax levy increase for the Village of St. Joseph, Champaign County, Illinois, for the 2006-2007 fiscal year will be held on November 28, 2006 at the hour of 7:00 p.m. at the Municipal Building, 207 E. Lincoln Street, St. Joseph, Illinois.

- II. The corporate and special purpose property taxes extended or abated for the 2005-2006 fiscal year were \$218,762.00.

The proposed corporate and special purpose property taxes to be levied for the 2006-2007 fiscal year are \$235,818.59. This represents a 7.64% increase over the previous year.

- III. The property taxes extended for debt service and public building commission leases for the 2005-2006 fiscal year were \$0.00.

The estimated property taxes to be levied for debt service and public building commission leases for the 2006-2007 fiscal year are \$0.00. This represents 0% increase over the previous year.

- IV. The total property taxes extended or abated for the 2005-2006 fiscal year were \$218,762.00.

The estimated total property taxes to be levied for the 2006-2007 fiscal year are \$235,818.59. This represents a 7.64% increase over the previous year.

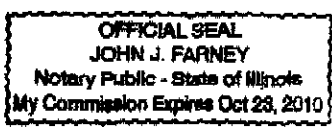
