

NOTICE OF PROPOSED PROPERTY TAX INCREASE FOR  
TOLONO PUBLIC LIBRARY DISTRICT

I. A public hearing to approve a proposed property tax levy increase for the Tolono Public Library District for 2006 will be held on September 5, 2006 at 7:00 P.M. at the Library, 111 East Main Street, Tolono, IL 61880.

Any person desiring to appear at the public hearing and present testimony to the taxing district may contact Janet Cler, Library Director, 111 East Main Street, Tolono, IL 61880, Ph. (217)485-5558.

II. The corporate and special purpose property taxes extended for 2005 were \$193,296.90.

The proposed corporate and special purpose property taxes to be levied for 2006 are \$216,500.00. This represents a 12% increase over the previous year.

III. The property taxes extended for debt service and public building commission leases for 2005 were \$0.

The estimated property taxes to be levied for debt service and public building commission leases for 2006 are \$0. This represents a 0% increase over the previous year.

IV. The total property taxes extended for 2005 were \$193,296.90.

The estimated total property taxes to be levied for 2006 are \$216,500.00. This represents a 12% increase over the previous year.


AN ORDINANCE TO LEVY AND ASSESS A TAX  
FOR THE TOLONO PUBLIC LIBRARY DISTRICT OF THE  
COUNTY OF CHAMPAIGN, STATE OF ILLINOIS FOR THE  
FISCAL YEAR BEGINNING JULY 1, 2006 AND ENDING JUNE 30, 2007

BE IT ORDAINED, that the Tolono Public Library District of the County of Champaign and State of Illinois shall levy a tax of .02% of the value of all taxable property within said District, for building and maintenance purposes, subject to the right of the electors in said District to petition and require an election concerning the imposition of such additional tax, pursuant to 75 ILCS 16/35-5.

BE IT FURTHER ORDAINED, that within fifteen (15) days from the date of adoption of the Ordinance, it shall be published in the Tolono County Star, a newspaper of general circulation in the Tolono Public Library District.

IN WITNESS WHEREOF, we have hereunder set our hands in Tolono, Illinois this 11th day of July, 2006.

1. The specific number of voters required to sign a petition requesting that the question of adoption of the resolution be submitted to the electors of the District is 614.
2. The petition must be filed on or before August 19, 2006.
3. The referendum would be held April 17, 2007.

ORDINANCE NO. 2006-09-05

ORDINANCE LEVYING AND ASSESSING MUNICIPAL TAX FOR  
THE TOLONO PUBLIC LIBRARY DISTRICT OF THE COUNTY OF CHAMPAIGN,  
STATE OF ILLINOIS FOR THE FISCAL YEAR BEGINNING  
THE 1st DAY OF JULY, 2006 AND ENDING  
THE 30th DAY OF JUNE, 2007

WHEREAS, the President and Board of Trustees of the Tolono Public Library District, in the County of Champaign and State of Illinois, did on the 8th day of August, 2006 pass the Annual Budget and Appropriation Ordinance (Ordinance No. 2006-08-08) for said Library District for the fiscal year commencing on July 1, 2006 and ending June 30, 2007; and

WHEREAS, said Annual Budget and Appropriation Ordinance was duly published as provided by law after its passage; and

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE TOLONO PUBLIC LIBRARY DISTRICT, IN THE COUNTY OF CHAMPAIGN AND STATE OF ILLINOIS, as follows:

Section 1: That the total sum of TWO HUNDRED SIXTEEN THOUSAND FIVE HUNDRED DOLLARS (\$216,500.00) composed as follows, be and the same is hereby levied and assessed upon and against all taxable property within this Library District according to the full fair value as established and ascertained for State and County purposes for the fiscal year beginning July 1, 2006 and ending June 30, 2007 and the Board of Trustees of the Tolono Public Library District having on the 8th day of August, 2006 duly passed and adopted the Annual Budget and Appropriation Ordinance for the fiscal year beginning July 1, 2006 and ending June 30, 2007 and said Ordinance having been duly published in a newspaper

of general circulation within this Public Library District. This Board finds that the specific purposes and the specific amounts provided for in said Annual Budget and Appropriation Ordinance, a copy of which is attached hereto and by this reference made a part hereof, are required to be levied for the necessary purposes of the Tolono Public Library District:

A. The sum of ONE HUNDRED NINETY-FOUR THOUSAND ONE HUNDRED FORTY DOLLARS (\$194,140.00) being the amount deemed required for the necessary Corporate purposes of the Tolono Public Library District:

**Section 3:** This Ordinance shall be in full force and effect on and after its passage and approval as provided by law.
