
Note Any district proposing to adopt a levy must comply with the provisions set forth in the Truth in Taxation Law

We hereby certify that we require:

the sum of 260,000 dollars to be levied as a special tax for educational purposes, and
the sum of 40,000 dollars to be levied as a special tax for operations and maintenance purposes; and
the sum of 20,000 dollars to be levied as a special tax for transportation purposes, and
the sum of 8,000 dollars to be levied as a special tax for a working cash fund; and
the sum of 2,100 dollars to be levied as a special tax for municipal retirement purposes, and
the sum of 15,000 dollars to be levied as a special tax for social security purposes; and
the sum of 8,000 dollars to be levied as a special tax for fire prevention, safety, energy conservation, disabled accessibility, school security and specified repair purposes; and
the sum of 120,000 dollars to be levied as a special tax for tort immunity purposes; and

the sum of 8,000 dollars to be levied as a special tax for leasing of educational facilities or computer technology or both, and temporary relocation expense purposes; and

When any school is authorized to issue bonds, the school board shall file a certified copy of the resolution in the office of the county clerk of each county in which the district is situated to provide for the issuance of the bonds and to levy a tax to pay for them. TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of Armstrong-Ellis Community Consolidated #1 (Legal Name of Taxing District), and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.
