MULTI-TOWNSHIP ASSESSMENT DISTRICT

ORDINANCE No. _____

An ordinance levying taxes for all assessment purposes for Ayers, Raymond, South Homer
Multi-Township Assessment District, Champaign County, Illinois, for the tax year
2007 collectable in 2008

BE IT ORDAINED by the Board of Trustees of Ayers, Raymond, S. Homer Multi-Township
Assessment District, Champaign County, Illinois as follows

SECTION 1 That the sum of Twenty-one thousand four hundred thirty five
and 00/100 Dollars (\$ 21,435.00) are hereby levied upon all
property subject to taxation within the Multi-Township Assessment District as that property is assessed and
equalized, in order to meet and defray all the necessary expenses and liabilities of the Multi-Township
Assessment District as required by statute, for the year 2008

SECTION 2: That the amount levied for each object and purpose shall be as follows:

SECTION 3: That the Clerk shall make and file with the County Clerk of said County of

Champaign, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of Ayers, Raymond, South Homer Multi-Twps Assessing Dist., (Legal Name of Taxing District), and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

Check One of the Choices Below:

- 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the "Truth in Taxation Law."
- 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.

- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the "Truth in Taxation Law."
