An ordinance levying taxes for all town purposes for Ayers Township,  
Champaign County, Illinois, for the tax year 2007, collectable in 2008.

BE IT ORDAINED by the Board of Trustees of Ayers Township,  
Champaign County, Illinois as follows:

SECTION 1: That the sum of Thirty four thousand four hundred forty and <sup>40</sup>/<sub>100</sub>  
Dollars (\$ 34,440 ) are hereby levied upon all property subject to taxation within the Township as that property is assessed  
and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted  
by the people in accordance with the law, for such purposes as:
