ANNUAL TAX LEVY ORDINANCE


For the levy and assessment of taxes for the fiscal year beginning May 1, 2008, and ending April 30, 2009, of the Carroll Fire Protection District, Champaign County, State of Illinois.

In pursuance of authority vested in them by "an act in relation to Fire Protection Districts," approved July 8, 1927, as amended, the Board of Trustees in meeting assembled, do hereby find and declare that there will be required to be raised by general taxation the amounts hereinafter set down, to be levied upon all taxable property in the said district, in order to meet and defray all necessary expenses and liabilities of said District as required by statute or voted by the people in accordance with the law, and the amounts so required are itemized and needed for uses and purposes as follows, to wit:

Making the amount to be raised by taxation and levied on all taxable property in said District, for the uses and purposes aforesaid, for the Corporate Fund, the sum of One hundred ten thousand seven hundred sixty dollars (\$110,760.00) and for the Liability Fund, the sum of Three thousand six hundred forty dollars (\$3640.00). And is hereby directed that the aforesaid sum be raised by taxation, in the manner provided by law.







TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of Carrol EPD, (Legal Name of Taxing District), and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

Check One of the Choices Below:

- 1) The taxing district's aggregate levy did exceed a 5% increase over the prior year's extension. Therefore, the district published a notice in the newspaper and conducted a hearing, meeting the requirements of the "Truth in Taxation Law."
- 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- 3) The *proposed* aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The *adopted* aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the "Truth in Taxation Law."
- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the "Truth in Taxation Law."
