ORDINANCE FOR THE LEVY OF TAXES FOR THE FISCAL YEAR May 3, 2007 THROUGH May 2, 2008, INCLUSIVE, OF THE CHERRY HILLS FIRE PROTECTION DISTRICT BE IT ORDAINED BY THE BOARD OF TRUSTEES OF CHERRY HILLS FIRE PROTECTION DISTRICT:

SECTION 1: That the following sums for the normal corporate objects and purposes hereinafter set forth and aggregating Twelve Thousand Two Hundred Fifty Dollars (\$12,250), be and the same are hereby assessed and levied for the normal corporate objects and purposes of the Cherry Hills Fire Protection District in Champaign County, Illinois, as hereinafter specified for the fiscal year commencing May 3, 2007, through May 2, 2008, both inclusive, upon all the real and personal property within the boundaries of the Cherry Hills Fire Protection District in Champaign County, Illinois, subject to taxation, and the objects and purposes for which said tax is levied and the amount levied for each object and purpose are as follows:

For normal corporate purposes:

Savoy Fire Department Contract	\$ 7,150
Fire Hydrant Rental	\$ 3,100
Miscellaneous Administrative and Operating Expenses	\$ 2,000
Total of budgeted items for Normal corporate purposes	\$ 12,250

SECTION 2: The Secretary of the District and of its Board of Trustees is hereby directed and commanded to certify and file with the County Clerk of Champaign County, Illinois, within the time provided by the law, a true, literal and correct copy of this Ordinance duly certified by said Secretary.

SECTION 3: This Ordinance shall be in full force and effect from and after its passage and approval.

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, EILEEN GOODCHILD, hereby certify that I am the presiding officer of Cherry Hills Fire Protection District, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.


