





ORDINANCE NO. 07-04

AN ORDINANCE LEVYING TAXES FOR ALL TOWNSHIP  
PURPOSES FOR CITY OF CHAMPAIGN TOWNSHIP,  
CHAMPAIGN COUNTY, ILLINOIS  
FOR THE TAX YEAR 2007, COLLECTIBLE IN 2008

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE CITY OF  
CHAMPAIGN TOWNSHIP, CHAMPAIGN COUNTY, ILLINOIS, as follows:

Section 1. That the sum of five hundred and seven thousand, nine hundred and seventy-five dollars and no cents (\$507,975.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law for such purposes as:

- General Town Fund
- General Assistance Fund
- Illinois Municipal Retirement Fund
- Social Security Fund

for the year 2008

Section 2. That the amount levied for each object and purpose shall be as follows:

Section 4. That if any section, subdivision, or sentence of this Ordinance shall for any reason be held invalid or be unconstitutional, such finding shall not affect the validity of the remaining portion of this Ordinance.


Section 5. That this Ordinance shall be in full force and effect after its adoption, as provided by law.

TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am the presiding officer of Town of The City of Champaign, (Legal Name of Taxing District), and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

Check One of the Choices Below:

- 1) The taxing district's aggregate levy did exceed a 5% increase over the prior year's extension. Therefore, the district published a notice in the newspaper and conducted a hearing, meeting the requirements of the "Truth in Taxation Law."
- 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.
- 3) The *proposed* aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The *adopted* aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the "Truth in Taxation Law."
- 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the "Truth in Taxation Law."

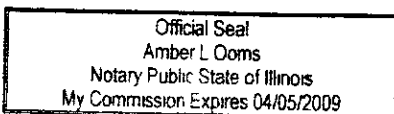

## **NOTICE OF PROPOSED PROPERTY TAX LEVY INCREASE FOR THE TOWN OF THE CITY OF CHAMPAIGN TOWNSHIP**

- I. A public hearing to approve a proposed property tax levy increase for the Town of the City of Champaign Township will be held on Tuesday, December 4, 2007 at 7:00 p.m. at the Champaign City Building, City Council Chambers, 102 North Neil Street, Champaign, Illinois.  
  
Any person desiring to appear at the public hearing and present testimony to the taxing district may contact Linda Abernathy, Township Supervisor, 603 S. Randolph St., Champaign, IL 61820 (217) 352-4500.
- II. The corporate and special purpose property taxes extended for 2006 were \$453,636.57.  
  
The proposed corporate and special purpose taxes to be levied for 2007 are \$507,975.00. This represents a 11.98% increase over the previous year.
- III. The property taxes extended for debt services, and public building commission leases for 2006 were \$0.  
  
The estimated property taxes to be levied for debt service, and public building commission leases for 2006 was \$0. This represents a 0% change from the previous years.
- IV. The total property taxes extended or abated for 2006 were \$453,636.57.  
  
The estimated total property taxes to be levied for 2007 are \$507,975.00 This represents a 11.98% increase over the previous year.
