An ordinance levying taxes for all town purposes for Colfax Township, Champaign County, Illinois, for the tax year 2007 collectable in 2008.

BE IT ORDAINED by the Board of Trustees of Colfax Township, Champaign County, Illinois, as follows:

SECTION 1: That the sum of Forty-six Thousand Three Hundred Thirty-four Dollars (\$46,334.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:
