An Ordinance levying taxes for all assessment purposed for Condit, East Bend, Hensley and Newcomb Multi-Township Assessment District, Champaign County, Illinois, for the Tax year 2007, collectable in 2008.

BE IT ORDAINED by the Board of Trustees of Condit, East Bend, Hensley, and Newcomb Multi-Township Assessment District, Champaign County, Illinois, as follows:

SECTION 1: That the Sum of Twenty Eight Thousand Five Hundred Seventy Six Dollars (\$28,576) are hereby levied upon all property subject to taxation within the Multi-Township Assessment District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Multi-Township Assessment District as required by statue, for the year 2008.

SECTION 2: That the amount levied for each object and purposed shall be as follows:

SECTION 3: That the Clerk shall make and file with the County Clerk of said County of Champaign, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That if any section subdivision or sentence of this ordinance shall for any reason be held validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.


CERTIFICATION OF TAX LEVY ORDINANCE
