

ORDINANCE 2007L

ANNUAL TAX LEVY ORDINANCE OF THE CORNBELT FIRE PROTECTION DISTRICT

An ordinance for the Levy of Taxes for the fiscal year beginning May 1, 2008 and ending April 30, 2009 for the CORNBELT FIRE PROTECTION DISTRICT of Champaign County, Illinois:

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the CORNBELT FIRE PROTECTION DISTRICT:

SECTION 1: LEVY: That there be, and there is hereby, levied at the rate of Thirty-Five Hundredths Percent (.35%) of the value of all property within the corporate limits of said CORNBELT FIRE PROTECTION DISTRICT, subject to taxation the total sum of Seven Hundred Sixty-four Thousand, Fifty-four dollars and 00/100 (\$764,054) for the following specific purposes mentioned in said Levy Ordinance in the respective sums as follows, to wit:

# TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE


I, the undersigned, hereby certify that I am the presiding officer of CORNBELT FIRE PROTECTION DISTRICT, and as such
