TAX LEVY ORDINANCE
TOWN OF CUNNINGHAM
(COLLECTIBLE 2008)

An ordinance levying taxes for all town purposes for the Town of Cunningham, Champaign County, Illinois, for the tax year 2007, collectible in 2008.

BE IT ORDAINED by the Township Board of the Town of Cunningham, Champaign County, Illinois, as follows:

SECTION 1: That, pursuant to the authority granted by the Township Code, Illinois Compiled Statutes, Chapter 60, Article 235, and such other statutes as are applicable, the sum one million seventy thousand dollars and zero cents (\$1,070,000.00) is hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

General Town Fund,	\$600,000.00
General Assistance Fund	\$470,000.00

for the tax year 2007, collectible in 2008.

SECTION 2: That the amount levied for each object and purpose shall be as follows:



TRUTH IN TAXATION CERTIFICATE OF COMPLIANCE

I, the undersigned, hereby certify that I am presiding officer of Cunningham Township, and as such presiding officer, I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

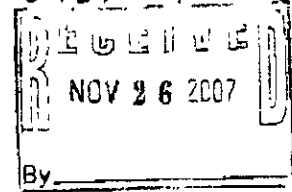

Notice of Proposed Property Tax Increase for the Town of Cunningham

- I. A public hearing to approve a proposed property tax levy increase for the Town of Cunningham for the tax year 2007 will be held on Monday, December 3, 2007 at 7:00 p.m. at the Urbana City Building, 400 South Vine Street, Urbana, Illinois.
Any person desiring to appear at the public hearing and present testimony to the taxing district may contact Carol Elliott, Cunningham Township Supervisor, 205 W. Green Street, Urbana, Illinois 61801. (217) 384-4144.
- II. The corporate and special purpose property taxes extended or abated for the tax year 2006 were \$981,884.56.
The proposed corporate and special purpose property taxes to be levied for the tax year 2007 are \$1,070,000.00. This represents an 8.9742% increase over the previous year.
- III. The property taxes extended for debt service and public building commission leases for the tax year 2006 were \$0.00.
The estimated property taxes to be levied for debt service and public building commission leases for the tax year 2007 are \$0.00. This represents a 0% increase over the previous year.
- IV. The total property taxes extended or abated for the tax year 2006 were \$981,884.56.
The estimated total property taxes to be levied for the tax year 2007 are \$1,070,000.00. This represents an 8.9742% increase over the previous year.
